WAIVER REQUEST FORM

GUIDELINES FOR WAIVERS

- 1) A Head Coach is not subject to the waiver rules if their children swim for the pool they coach.
- 2) Each team is limited to a maximum of ten waiver families.
- 3) A waiver applies to all swimmers in the same immediate family.
 - a. Where multiple families reside in the same household, each must receive their own waiver.
- 4) A family is only permitted to waiver to a single pool. If a family fails to waiver in a subsequent season they will be reassigned to their home pool and they cannot waiver again.
- 5) Families who received a waiver in the previous season have priority over new waivers until the last scheduled registration session, or June 15th, whichever is later, after which remaining waiver slots are issued on first-come first-served basis, subject to review by the head coaches.
- 6) The head coach from both the home pool and the waiver pool must sign the waiver.
 - a. If there is not an agreement between head coaches, a head coach can submit the waiver request to the Vice President of the objecting coach's section for review and possible override.
 - b. If the conflict remains unresolved, the waiver request may be presented to the Board for appeal.

RESPONSIBILITIES OF WAIVER FAMILIES

1) An adult member of the family or an adult substitute is <u>required</u> to assist in the running of the team and to volunteer at all LSA meets, listed below, regardless of whether their own children are swimming.

- 2) The participation at meets may be in the capacity of a timer, runner, table person, or whatever the needs of the meet director may require and skills of the participant may allow. If a waiver family is not able to make a scheduled meet, the waiver family must arrange for an appropriate substitute to serve in their place and provide the substitute's name to the head coach.
- 3) If a waiver family does not meet the responsibilities of the waiver, the head coach can refuse to accept their waiver the following season and the family will be reassigned to their home pool.
